## **General provisions:**

1. The information you provide will be treated in the strictest confidence. Only complete registration forms (with accompanying documents) will be processed.
2. The requested documents are necessary to assess whether the applicant(s) may be eligible for renting a home.
3. No right to allocate a home can be derived from signing this form.
4. An application can be rejected without stating reasons.
5. In connection with the Personal Registration Act, the undersigned(s) are aware that the information provided is included in the administration of Liprice Vastgoed BV.
6. By signing this registration form you authorize the owner of the real estate object to have a risk analysis carried out relating to the payment/rental behavior of the applicant. There is no cost to the applicant for this risk analysis. The applicant is aware that the results of the risk analysis may give the landlord reason not to allocate the house, or to impose further conditions on this.
7. All oral communications regarding the rental of a home are deemed to have been made subject to permission being granted by the rightful claimant. If it turns out afterwards that no permission has been obtained, the rental will be deemed not to have been concluded and no rights can be derived from any communication on our part towards us or towards third parties, whoever, in the broadest sense of the word.
